By using the Services and the Site, you confirm that you accept these terms of use and that you agree to comply with them.

If you do not agree to these terms of use, you may not make use of our Services or the Site.

#### Changes to These Terms

We may revise these terms of use at any time by amending this page.

Please check this page from time to time to take notice of any changes we make, as they are binding on you.

## Changes to the Site

We may update the Site from time to time and may change the content of it at any time. However, please note that any of the content on the Site may be out of date at any given time, and we are under no obligation to update it.

We do not guarantee that the Site, or any content on it, will be free from errors or omissions.

#### The Services

Following receipt of a system water sample together with a fully completed Water Test Kit Form (which is provided in the Water Test Kit), Adey will undertake testing. A test result of any water sample that has been dosed with Adey chemicals will be posted on the Site where it can be accessed using your personal log in. The test result of any water sample dosed with non-Adey chemicals will not be posted on the Site

Please note that the Services provide indicative water test results which are within set parameters and are not diagnostic test results.

We will use reasonable endeavours to complete all testing within 24 hours of a sample being received by us and will use our reasonable endeavours to upload the result of the test as soon as reasonably practicable thereafter. Time shall not be of the essence for the purposes of undertaking the test and providing you with the test result.

We will send you an email notification once the test result is available on the Site, to be accessed via your personal log in.

Adey will not be liable to you for any losses whatsoever as a result of your Water Test Kit being lost or damaged whilst in transit to us.

We cannot guarantee that we will be able to successfully complete the test, and publish the result, if:

- You have failed to fully follow the instructions contained within your Water Test Kit;
- You have failed to fully, accurately or legibly complete the Water Test Kit Form, included in your Water Test Kit, and return it with the water sample you wish to be tested;
- You have taken an insufficient quantity of water to be tested;
- You have provided us with an email address on the Water Test Kit Form that is different to that you use to log on to the Site;
- We have reason to believe that the water sample you have supplied has been doctored, tampered with, treated otherwise than in accordance with the Water Test Kit instructions, and/or taken from a location other than that as informed to us on the Water Test Kit Form submitted with the sample for testing.

Adey will not be liable for any loss in any form whatsoever should it be unable to complete the testing of any water sample you provide to us as a result of your failure to comply with the above.

For the avoidance of all doubt, once the water sample you have provided to us has been tested or rejected due to it being unsuitable or not compliant with the above requirements or any requirements outlined in the instructions supplied with the Water Test Kit, all samples will be destroyed. Adey does not, and will not, retain any water samples.

# Accessing the Site

The Site is made available for your use free of charge.

To use the Site you will need to register by providing:

- Your full name;
- Your full address;

- Your contact telephone number.

Upon submitting the above information you will be requested to create a password, unique to you, which you will use to access your personal section of the Site where you can view and download all your test results. This password must be kept confidential to you only, and must not be shared with anyone else. If we have reason to believe that you have provided your login details to someone else, or your account has been compromised, we reserve the right to suspend your access to the Site. We will not be liable for any losses that may arise as a result of this suspension.

We do not guarantee that the Site, or any content on it, including current or previous test results, will always be available or be uninterrupted.

We may suspend, withdraw, discontinue or change all or any part of the Site without notice.

We will not be liable to you if for any reason the Site is unavailable at any time or for any period.
